**Chairman’s Report:**

- A. A FOIA request was submitted to the West Central Development Council executive director on May 21, 2019 requesting information related to the filing of a complaint against involving one or more Economic Development Administration representatives. The WCDC governing board granted no such authorization to file a complaint. The WCDC has provided no satisfactory response to the FOIA request. With the lack of response by the WCDC executive director, coupled with the absence of an updated “Comprehensive Economic Development Strategy” (CEDS) document, necessary for EDA grant eligibility, the County Board is requested to authorize the withholding of dues payments to WCDC until such time that WCDC presents a viable plan to produce an updated and usable CEDS document.
