- A. The Treasurer has confirmed the receipt of \$3.4 million dollars to Jersey County from the proceeds of bonds sold for the improvements and repairs to the jail and courthouse. Meetings have been held with officials in the Courthouse and Sheriff regarding the anticipated schedule of work activity in both venues in order to adjust respective service activity of each office.
- B. Appointment of Kelly Birdsong, EMS coordinator at Jersey Community Hospital, to fill the balance of a term on the 911 ETSB Board, expiring on December 31, 2021.
- C. Appointment of Assistant State’s Attorney Kevin Tellor to serve in the capacity of Ethics Advisor/Officer, as prescribed by the existing Ethics Ordinance adopted on November 10, 2004. The term of appointment will expire on December 31, 2022.
- D. Appointment of County Board Member Sandy Hefner to County Service Offices and Public Safety Committee.
